### Course overview

**Catalog Description:** Origin and development of the Texas constitution, structure and powers of state and local government, federalism and inter-governmental relations, political participation, the election process, public policy, and the political culture of Texas. (4510025125)

**Textbook:** *Governing Texas*. Champagne, Harpham, and Casellas. Norton. 4th Edition.

**Course Expectations:** Government 2306 will provide an introduction to the state politics of Texas. This course covers the history, governing institutions, political trends, and ideals of Texas, as well as the state government's relation to the federal government of the United States. Students will learn about Texas foundations and functions of the major institutions of our state government; about the political processes that involve the participation of political parties, interest groups, and voters; and about the major problems and challenges facing Texas at the state level of government. This course emphasizes the development of intellectual, academic, social, and civic skills. The specific course expectations include: 1) To nurture the student's ability to read critically, think rationally, and communicate effectively, 2) To provide problem-solving opportunities that will challenge students to think analytically, while encouraging intellectual risk-taking, 3) To encourage student responsibility for learning, 4) To foster civic participation, 5) To develop a commitment to civil dialogue and willingness to express ideas and consider opposing viewpoints.

## Student Learning Outcomes:

1. Explain the origin and development of the Texas constitution
2. Describe state and local political systems and their relationship with the federal government.
3. Describe separation of powers and checks and balances in both theory and practice in Texas.
4. Demonstrate knowledge of the legislative, executive, and judicial branches of Texas government.
5. Evaluate the role of public opinion, interest groups, and political parties in Texas.
6. Analyze the state and local election process.
7. Identify the rights and responsibilities of citizens.
8. Analyze issues, policies and political culture of Texas.

**Technology:** Students will utilize D2L to access the course grade book. Students will utilize the instructor's website to access course readings, Power Point presentations, etc. Students will be expected to use Microsoft Word to type and submit Current Event Analyses. Students may be asked to view videos and/or documentaries on YouTube.

## Instructor guidelines and policies

**Assignments:** There will be three Current Event Analyses, three Pop Quizzes, two tests, one Policy Presentation, and one final exam. The first two tests will be multiple-choice and short-answer. The multiple-choice questions will come from the textbook *Governing Texas*, class lecture notes, and other reading assignments. The short-answer prompts will pertain to primary and secondary sources. The third test will be a Policy Presentation that requires students to choose a research topic, summarize the topic, and provide policy recommendations. The final exam will be comprehensive and multiple-choice only. The Current Event Analyses will generate informal discussion that contributes to the participation grade in the course. Pop quizzes will also contribute to the participation grade in the course.

**Missed and Late Assignments:** Students wishing to re-schedule a missed test must do so within 48 hours of the assignment and have no more than 1 week to complete the assignment. If the student fails to schedule the make-up and/or fails to complete the assignment within 1 week, they may receive partial or no credit at the instructor's discretion. Assignments that are submitted late will have 10 points deducted per class day.

**Attendance and Participation:** Students are expected to attend class, arrive on time, and not leave early. Students with excessive attendance problems (as defined by the instructor) may lose points on their participation grade.

**Classroom Etiquette:** The instructor intends to begin class on time each day and students should be ready for class when it begins. If a student arrives late they should enter the classroom as quietly as possible. If a student needs to leave class early they should inform the instructor. Students should not be using computers or cell phones for non-academic reasons during class. Students should use academic language in written assignments and oral participation. Students should show respect, compassion, and patience toward their peers in class discussions. The instructor intends to facilitate civil dialogue and cultivate a commitment to free speech.

**Withdrawal Policy:** The last day for students to withdraw from this class is **November 11**. The Texas Legislature enacted campus carry by passing Senate Bill 11, effective at LSC on August 1, 2017. Senate Bill 11, known as the "Campus Carry" law, amends Texas law to allow license holders to carry concealed handguns on college campuses.
